- Copy of Driver's License\*\*
- Original** Golf ID card\*
- Check payment (made payable to Bergen County Department of Parks)

\*\*For Residents: In lieu of a driver's license, must provide **two** of the following documents with name and BC address listed: Current Deed to Residence, Current Lease to Residence, Current Residential Property Tax Bill, Current Utility Bill, or Current W-2 or 1099 Statement **and** an official photo ID.

\*\*Juniors need to provide copy of birth certificate and also copy of school ID; report card or library card and the parent must provide copy of driver's license to verify residency. **A Junior golfer must play with an adult golfer aged 18 or older until the Junior golfer is 15 years old.**

**\*If you DO NOT have a golf ID card you must RENEW IN PERSON, and if you have LOST your golf ID card, there will be an additional \$25 replacement card fee.**

## **NEW REGISTRATIONS:**

**NEW REGISTRATIONS MUST BE DONE IN-PERSON AT THE GOLF COURSE – BRING THE FOLLOWING:**

- Completed Form
- Driver's License\*\*
- Credit card or cash for payment

\*\*For Residents: In lieu of a driver's license, must provide **two** of the following documents with name and BC address listed: Current Deed to Residence, Current Lease to Residence, Current Residential Property Tax Bill, Current Utility Bill, or Current W-2 or 1099 Statement **and** an official photo ID.

\*\*Juniors need to show copy of birth certificate and must also provide school ID, report card or library card and a parent must show driver's license to verify residency. **Junior golfers must play with an adult golfer aged 18 or older until the Junior golfer is 15 years old.**

**\*\*Current Active US Armed Forces ID required.**

**\*\*Military Veteran Status ID required, along with residency proof.**

**RESIDENT DISABILITY REGISTRATIONS:** A Disabled Golf ID card with discounted greens fees is available if Resident has been declared 100% disabled and is currently receiving full disability benefits from Social Security. A Social Security Awards letter is required to qualify. Previously issued disability registrations may be renewed at the golf courses. New disability registrations are only issued at the golf course with the required documentation and approval by golf course manager. **A registration fee applies and is based on resident age category.**
